Voters will decide on HJR4 Constitutional Amendment on Nov 2

Since the 2006 court decision that reinterpreted Article VIII, Section 3, hospitals have been limited in their ability to replace or acquire new medical equipment, improve facilities and technology, or expand services without a vote to approve these improvements when financed for over 12 months.

With the current interpretation of the law, public hospitals are not allowed to enter into purchasing agreements exceeding 12 months. That means anything from leasing a copier or patient transport van to purchasing advanced imaging equipment, expanding emergency rooms or adding needed services like dialysis or cancer treatments, hospitals need to either pay the entire amount up front to purchase or enter into small leases less than 1 year that don't provide hospitals with the most cost effective terms.

Without the amendment, hospitals are required to get a 2/3 approval of the electorate in each instance where financing in excess of 12 months would be needed, despite the fact that no additional tax dollars will be required. Learn more about this issue at www.whatisHJR4.com.

Rural Outreach Grant - Summer 2011

HRSA will be making available the Rural Outreach Grant applications in Summer 2011. The purpose of the Outreach program is to promote rural health care services outreach by expanding the delivery of health care services to include new and enhanced services in rural areas. Applicants may propose projects to address the needs of a wide range of population groups including, but not limited to, low-income populations, the elderly, pregnant women, infants, adolescents, rural minority populations and rural populations with special health care needs. The services may include: health education and promotion, health screenings, health fairs, and training and education to providers, among other activities. Typically, this grant opportunity is for a three-year grant and approximately \$150,000 a year for the project. IRHA Models Youth Suicide Prevention Forum in Maine

In Idaho, the program has been presented in Eagle, Plummer, Emmett, St. Maries and Meridian. The information is geared towards adults and is offered at no cost to communities. Continuing education credits are available for attendees.
