NRHA Idaho Site Visit

Representatives from the National Rural Health Association (NRHA) and the Federal Office of Rural Health Policy (FORHP) participated in a joint site visit to rural programs in Idaho, August 8-9, 2016. The purpose of this effort was to discuss and observe the impact and implementation of rural policies and programs in the state. The tour included an initial day of presentations to provide background and updates on current models and policies that are in effect. Mary Sheridan, Bureau Chief, Bureau of Rural Health & Primary Care at the Idaho Department of Health & Welfare and Dr. David Schmitz, Chief Rural Officer, Rural Training Track Program Director, and Chief Quality Officer at the Family Medicine Residency of Idaho (FMRI) in Boise assisted with the coordination of the site visit. Presentations included: an overview from Dr. Ted Epperly, President and CEO of FMRI; a discussion from representatives of the Idaho Department of Health & Welfare on the Statewide Healthcare Innovation Plan (SHIP); graduate medical education; rural health initiatives and public perspectives; reimbursement; rural health workforce; quality, payment and an opioid initiative from a Critical Access Hospital perspective and an update from Executive Director, Shannon Schmitz with the Idaho State Rural Health Association. The second day included site visits to the Twin Falls Rural Training Track; the Jerome Rural Training Track; the Shoshone Family Medical Center and Lost Rivers medical Center in Arco.

The discussions provided an important perspective for both the NRHA and the FORHP leadership to better understand how rural health policies and programs are unfolding in rural areas. Idaho is known for having a unique collaboration between federal, state and local entities that have led to successful funding streams for improving access to health in rural areas. The opportunity to see some of these programs firsthand reaffirmed the commitment of the NRHA to continue to highlight what is working in rural America that needs to be addressed to ensure that these programs are sustained long term. As the NRHA also provides funding through subawards to some of the Rural Training Track Programs in the state as well as technical assistance to the Idaho State Rural Health Association through a cooperative agreement from the FORHP, the listening sessions and the visits made for a meaningful education of how these successful collaborations might inform future policies and innovation.

2016 National Rural Health Day 4th Annual Idaho Photo Contest

The Idaho Rural Health Association (IRHA) announces the fourth annual Idaho Rural Health Day Photo Contest. National Rural Health Day is an initiative to showcase rural America and unique efforts to address rural healthcare needs. This photo contest is a creative opportunity to celebrate the power of rural and visually share what rural health in your Idaho community means to you. These photographs will be showcased on the IRHA and Bureau of Rural Health & Primary Care websites.

Contest Deadline and Eligibility

The deadline for photo submission is **Monday, November 14th, 2016 at 5pm MT**. More than one person in an organization can submit a photo, however, only one photo can be submitted per person. The photo must convey the concept of rural health in Idaho at a glance.

Judging

A Review Committee will select a winner prior to November 17th, 2016. Photos will be judged based on creativity, originality, photo quality, and how well the photo communicates the concept of rural health in Idaho. The most competitive submissions will demonstrate the unique efforts of rural healthcare in Idaho without the need for lengthy captions.

Submitting Photos

To submit a photo, send a high resolution version of the photo in a .jpg file format (maximum 2 MB) to ruralhealth@dhw.idaho.gov. With the photo, include the location, a caption, and any additional information you feel is relevant. In addition, please include your name, e-mail address, and phone number. By submitting the photo, you adhere to the information listed in the "use of copyrighted materials" section below.

Use of copyrighted materials

The photo must have been captured by the individual submitting to the contest. Images submitted must be royalty-free. Only photos meeting these requirements will be eligible for prizes and qualify for the National Rural Health Day Idaho Photo Contest. The IRHA and the Bureau of Rural Health & Primary Care will use the photos submitted to the contest on their websites and in their publications.

Prizes

The grand prize for the National Rural Health Day Photo Contest is a **\$50 Gift Card**. Second place will receive a **\$25 Gift Card**. Contest winners will be notified on National Rural Health Day, Thursday, November 17th and publicized on the IRHA and the Bureau of Rural Health & Primary Care websites.
